Features & Benefits

Installation tips

- Install vertically with cartridge hanging
- Allow 64mm clearance below the cartridge for easy cartridge replacement.
- Flush cartridge by running water through filter for thirty (30) minutes at full flow.

Operation tips

- Change cartridges on a regular 6-12 month preventative maintenance program.
- The service life is the recommended replacement cycle. The actual service life of the cartridge will vary depending on the actual water usage conditions and local tap water quality
- Change cartridges when capacity is reached or when pressure falls below 10 psi (0.7 bar).
- Always flush the filter cartridge at time of installation and cartridge change
